TEMPORARY CONSTRUCTION EASEMENT

THIS TEMPORARY CONSTRUCTION EASEMENT AGREEMENT (the "Agreement") made, between MELVIN SPIRA TRUSTEE, LLP, fee owner of a certain 91.09 acre parcel of land (the "Property") and Zdunkewicz Farms, lessee in possession of a portion of the Property impacted by the rights to be granted herein, (collectively referred to herein as "Grantor"), and the FORT BEND COUNTY DRAINAGE DISTRICT, (herein called "Grantee"), whose mailing address is 301 Jackson Street., Richmond, Texas 77469, WITNESSETH:

Grantor for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other valuable consideration in hand paid to it by Grantee, the receipt of which is hereby acknowledged does hereby grant unto the said Grantee, its successors and assigns, a temporary non-exclusive construction easement (the "Easement") being approximately 3.2 acres as depicted on Exhibit "A" (the "Easement Area"), attached hereto and made a part hereof, for the purpose of stockpiling spoil related soil or dirt from the Big Creek Improvement Project, to wit:

ATTACHED AS EXHIBIT "A"

together with the rights of ingress and egress to the above described Easement herein granted.

TO HAVE AND TO HOLD said rights and privileges, unto Grantee, its successors and assigns until Grantee releases said Agreement by an instrument in writing, duly recorded, subject to the following conditions, within twelve (12) months beginning November 1, 2016:

- 1. The Term of this Easement granted herein shall be for a period of twelve (12) months commencing upon the date of execution of this Agreement and expiring automatically on the expiration or earlier termination of this Easement (unless otherwise extended in writing between Grantor and Grantee) without further action required by either party.
- 2. Grantor reserves the right to occupy, use and cultivate the Easement Area for all purposes not inconsistent with the rights herein granted. However, Grantor's use of the Easement Area shall not materially interfere with the use and quiet enjoyment of the Easement Area by Grantee, its employees, tenants, invitees, contractors or representatives.
- 3. It is understood and agreed that this grant is not a conveyance of the lands described herein or of any interest in the oil, gas and other minerals in, on or under said lands, but is a grant solely of the Easement granted herein. This grant is made subject to all applicable laws, ordinances, easements, leases, restriction, reservations or covenants, either of record or evidenced by improvements upon the ground and to the extent same are in force, regarding the storage of dirt or soil owned by Melvin Spira Trustee, LLP as and when removed from creek bank.
- 4. It is agreed that this Agreement covers all agreements between the parties and no representations or statements, verbal or written, have been made, modifying, adding to, or changing the terms of this Agreement.


