- **Homestead Exemption: \$5,000 or 20 percent (whichever is greater); and**
- **Over 65 Exemptions: \$100,000; or**
- **Disabled Person Exemption: \$100,000.**

Duly put and unanimously carried (5-0), it is ordered to approve the adoption of Local Option Exemptions for the Fort Bend County Drainage District property taxes for the 2017 Tax Year as follows, pursuant to Section 11.13(n) of the Texas Property Tax Code:

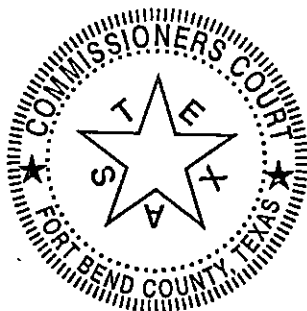
- Homestead Exemption: \$5,000 or 20 percent (whichever is greater); and
- Over 65 Exemptions: \$100,000; or
- Disabled Person Exemption: \$100,000.
