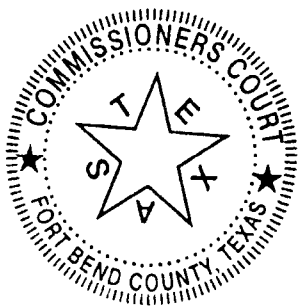
Commissioner Meyers asked if the County will apply for reimbursement for these costs.
