Any revision of the bond amount shall not be cumulative.

whom this bond is payable stating that, not less than thirty (30) days thereafter, the Surety's liability hereunder shall

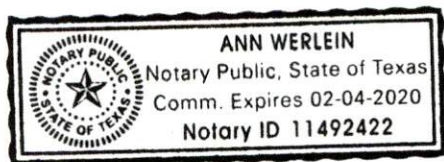
