General Notes

1. **WORKERS AHEAD** Sign may be installed at less or more than 100 feet in the approach to the work zone if visibility or the work zone is less than 1500 feet. Sign R20-3 should precede all signs.
2. Flaggers should use two-way radios or other method to communicate.
3. Length of work area should be based on the ability of flaggers to communicate.
4. Distances along curve or area of obstruction should be long enough to develop enough time for a motorist to identify and react to flagger signals.
