THIRD AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and HR Green, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on January 27, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; as amended by documents dated October 13, 2015, (hereinafter "Amendment") and April 26, 2016, (hereinafter "Second Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided, including water line and traffic control revisions to the final design plans.

NOW. THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Contractor an additional fifteen thousand three hundred dollars and no/100 (\$15,300.00), for the additional services to be rendered under the Agreement as described in the fee estimate attached as Exhibit "A" hereto and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred sixty-seven thousand seven hundred forty seven dollars and no/100 (\$483,047.00), allocated as follows:
 - A. \$368,901.00 under the Agreement;
 - B. \$93,846.00 under the Amendment;
 - C. \$5,000.00 under this Second Amendment; and
 - D. \$15,300.00 under this Third Amendment.
- 3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further amendment executed by the parties.
- 4. The Time of Performance for all Services to be provided by Contractor, including the additional services, is hereby extended an additional twenty-four (24) months from the original date of termination as provided in the Agreement.

Except as provided herein, all terms and conditions of the Agreement and subsequent Amendments shall remain unchanged.
