**THIRD AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Half Associates, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on June 2, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; as amended by documents dated December 1, 2015, (hereinafter "Amendment") and September 6, 2016, (hereinafter "Second Amendment"); and

WHEREAS, the parties desire to further amend the Agreement to include additional services to be provided by Contractor.


NOW, THEREFORE, the parties do mutually agree as follows:

1. Services to be rendered under the Agreement shall be amended to add design services beyond the original scope of work, as described in the Supplemental Proposal for Additional Services dated December 15, 2016, attached hereto as Exhibit A, and incorporated herein for purposes.
2. County shall pay Contractor an additional eight thousand two hundred dollars and no/100 (\$8,200.00), for the additional design services to be rendered under this Amendment.
3. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred thousand four hundred fifty dollars and no/100 (\$400,450.00), allocated as follows:
 - A. \$325,000.00 under the Agreement;
 - B. \$29,000.00 under the Amendment;
 - C. \$38,250.00 under the Second Amendment; and
 - D. \$8,200.00 under this Third Amendment.
4. The Time of Performance for Contractor to complete all Services under the Agreement and subsequent Amendments is hereby extended by an additional twelve (12) months for a total of thirty-six (36) months from the date of Contractor's initial receipt of the Notice to Proceed under the Agreement.
5. In no case shall the amount paid by County for all Services under the Agreement or the subsequent Amendments exceed the Maximum Compensation without a written agreement signed by the parties.



Attachment 'A'

Scope of Work for Beechnut Additional Services

Halff Associates, Inc. (Halff) has been contracted with Fort Bend County for engineering services to design a segment of Beechnut Street from F.M. 1464 to Lobera Drive. During the final design phase, it was discovered that a portion of the existing storm sewer system adjacent to the project area on Clodine Rd was constructed in a manner that does not allow the system to adequately drain. Halff will extend the proposed storm sewer design on Beechnut Street to include reconstruction of this additional area on Clodine. The scope of work below describes the additional services required to be completed during the final design phase.

Additional Storm Sewer Design

The proposed storm sewer design area will be extended to include the south side of Clodine Road adjacent to the original project area.

Tasks included in the design

1. Design storm sewer system to drain the portion of Clodine Rd just south of Beechnut Street
2. The design will include replacement of approximately 2 curb inlets, 2 manholes, and associated storm sewer pipe to connect this system to the proposed Beechnut system.
3. Additional phases will be added to the Beechnut Street traffic control plan to accommodate the construction of the additional storm sewer.
4. Street cuts will be required on the existing Beechnut section and Clodine Rd
5. Beechnut Street hydraulic calculations will be updated to include the additional proposed storm sewer

Tasks excluded from the design

1. Existing storm sewer modifications beyond what is necessary to allow the added area to drain to the proposed Beechnut system
2. Roadway modifications to exiting Beechnut Street and Clodine Road beyond what is required to construct the proposed storm sewer.
