## AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Van De Wiele & Vogler, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on October 6, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to amend the Agreement to increase the total Maximum Compensation to cover the increased cost for developing right of way acquisition documents.

#### NOW, THEREFORE, the parties do mutually agree as follows:

- County shall pay Contractor an additional two thousand eight hundred sixty dollars and no/100 (\$2,860.00) for the additional costs to develop the right of way and easement acquisition documents as described in the proposal dated September 1, 2016 attached hereto as Exhibit "A" and incorporated herein for all purposes.
- The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed seventy-eight thousand three hundred eighty-two dollars and no/100 (\$78,382.00), authorized as follows:

\$75,522.00 under the Agreement; and \$2,860.00 under this Amendment.

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further written agreement executed by the parties.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
