Here is the information on up coning training that is scheduled that we could use extra funds on.

1 officer for the Texas CIT Conference: Conference cost \$180.00 Hotel and meals for 4 nights approximately

\$600.00

Total 780.00

2 officers for civil process training with Texas Justice Court Training approximately \$500.00 an officer for hotel and meals, class cost already paid for. Total \$1,000.00

1 officer for Taser Recertification as an instructor class \$225.00 plus meals \$63.00 for meals 2 days Total \$288.00 Plus the cost of myself just going to Newly Elected Constable Training in Huntsville to keep this money from coming out of LEOSE funds Hotel \$502.00 and meals \$198.00 Total \$700.00

If the \$700 comes out of LEOSE I will have spent \$3,000.00 out of my LEOSE account, if not I would have still spent \$2,300 out of LEOSE this year, since January 1, 2017. I really do not want to spend any more out of LEOSE money. All the above is already scheduled.

I would expect at least 2 other officers to attend training before the budget cycle is over either with Public Agency Training Council, TJCT or a different seminar, I would think that cost depending on cost of class, with hotel and meals approximately \$750.00 per officer Total \$1500.00

I currently still have \$397.32 in training and travel line item.

The amount I would like to add to my budget for training and travel expense for the remainder of 2017 is \$4268.00 All of this is in state training. The minimum I am asking for is \$3000.00.

Just for FYI I am increasing 2018 budget to \$8,000 for training and travel for my department with 20 total employees, that is an average of \$400.00 per person.
