THAT, SUGAR LAND RANCH DEVELOPMENT II, CORP. ("Grantor"), a Texas corporation, for and in consideration of the sum of TEN DOLLARS (\$10.00) and other valuable consideration to the undersigned in hand paid by the Grantee herein named, the receipt and sufficiency of which are hereby acknowledged, has DONATED, and by these presents does GRANT, GIVE AND CONVEY unto FORT BEND COUNTY, TEXAS ("Grantee"), a body corporate and politic under the laws of the State of Texas and unto its successors, and assigns, forever, a certain tract of land, containing 0.0319 acres, as more particularly described in Exhibit "A", attached hereto and incorporated herein and made a part hereof for all purposes, together with all rights, titles, and interests appurtenant thereto and improvements situated thereon (collectively, the "Property").

METES AND BOUNDS FOR 0.0319 ACRES

Being a 0.0319 acre tract of land located in the William Little Survey, Abstract-54, in Fort Bend County, Texas; said 0.0319 acre tract being a portion of a call 597.7707 acre tract of land recorded in the name of Sugar Land Ranch Development II Corp., in Clerk's File Number 2006092799 of the Official Records of Fort Bend County (O.R.F.B.C.); said 0.0319 acre tract being more particularly described by metes and bounds as follows (all bearings are based on the Texas Coordinate System, South Central Zone and referenced to the south Right-of-Way (R.O.W.) line of University Boulevard as recorded in Plat Number 20120117 of the Fort Bend County Plat Records):

Beginning at a 5/8-inch iron rod with cap stamped "COSTELLO INC" found at the most westerly end of a radius return at the southwest corner of LJ Parkway (105-feet wide) and University Boulevard (120-feet wide) as recorded in Plat Numbers 20120039 and 20120177 of the Fort Bend County Plat Records;

Thence, with said radius return, 24.91 feet along the arc of a curve to the right, said curve having a central angle of 40 degrees 46 minutes 12 seconds, a radius of 35.00 feet and a chord that bears South 83 degrees 35 minutes 35 seconds East, a distance of 24.38 feet to a 5/8-inch iron rod with cap stamped "COSTELLO INC" set;

- 4. 16.83 feet along the arc of a curve to the right, said curve having a central angle of 01 degrees 53 minutes 26 seconds, a radius of 510.00 feet and a chord that bears South 75 degrees 51 minutes 22 seconds West, a distance of 16.83 feet to a 5/8-inch iron rod with cap stamped "COSTELLO INC" set;
