



4. **Public Comments regarding the Agenda and Announcements.**

Judge Hebert recognized four Health and Human Services staff, David Olinger, Anthony Ryder, Yaneth Calderon and Cynthia Smith for meeting the project criteria with outstanding contributions to local health prepared efforts. This is a joint project of NACCHO and Center for Disease Control which determines if the County is prepared for health emergency. There are over 305 points tested in the Health and Human Services operation to determine if we are ready. Only 35 organizations in the US received this recognition.

Judge Hebert announced Pamela Gubbels, Director of Finance and Investment and her staff received from the Government Finance Officers Association the Distinguished Budget Presentation Award for meeting the highest principals for government budgeting. This is the 16th consecutive year Fort Bend County Budget Office has received this award.

Judge Hebert expressed condolences to the family of Charlie Howard, State Representative. Judge Hebert recognized Mr. Howard as a giving public servant for many years and represented Fort Bend County very well in Austin.

Commissioner Patterson stated he went to vote in the afternoon yesterday and was the second person to vote. Today is the last day for early voting.

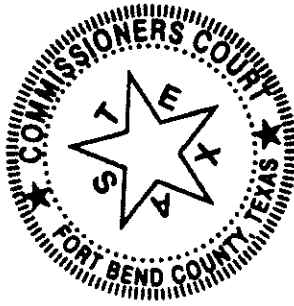
