Dear Valued Chevron Lubrication Marketer:

Chevron is announcing a general price increase of all lubricating oils and greases from 4% to 6%, to be effective May 15th, 2017. In certain instances, specific products may increase in amounts that are outside of this general parameter.

This price movement is being driven by increasing costs of raw materials which impact the manufacturing of our products.

We understand and appreciate the efforts required by our Marketers to communicate this increase to your customers.

Please note:

- To manage our order fulfillment and to provide the ability to meet the needs of all of our customers, we would appreciate that you place your orders consistent with historical order patterns. In order to serve all Marketers, we will be limiting orders delivered between April 3rd, 2017 and May 12th, 2017 to 115% of your average monthly volume over the last twelve months. Marketers that exceed the above limit will be billed at the new posted price effective May 15th, 2017.
- Your average monthly volume is defined as your average monthly purchases from April 1st, 2016 to March 31st, 2017. Details regarding your average monthly volume are available to you through your LBST Account Coordinator.
- Please plan accordingly as large order quantities placed the week prior to the increase will be reviewed and may not be accepted by Chevron in order to better meet all customers' needs.




