**SECOND AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL TRAFFIC SIGNAL DESIGN SERVICES**

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and EPIC Transportation Group, LP, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on October 11, 2016, (hereinafter "Agreement"), as amended by document dated April 4, 2017, (hereinafter "Amendment"); and


WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:


1. County shall pay Contractor an additional eleven thousand five hundred eighty dollars and no/100 (\$11,580.00) for the additional design services as described in the proposal dated May 16, 2017, attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed one hundred fifty-one thousand four hundred fifty-two dollars and no/100 (\$151,452.00), authorized as follows:
 - \$132,372.00 under the Agreement;
 - \$7,500.00 under the Amendment; and
 - \$11,580.00 under this Second Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement, the Amendment and this Second Amendment exceed the Maximum Compensation without an agreement executed by the parties.

Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.

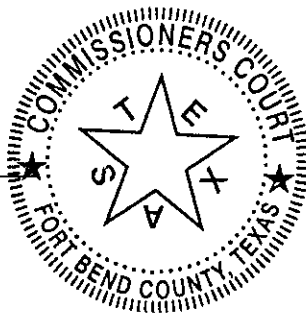



Dear Rick:

EPIC Transportation Group (EPIC) appreciates the opportunity to submit this proposal to perform "additional" engineering services related to "Traffic Signal Installation and Related Improvements" at the above location in Fort Bend County, TX. The engineering services to be provided by EPIC are for the 1) Additional Design Phase, 2) separate Contract Phase and 2) separate Construction Phase.

SCOPE OF SERVICES

- EPIC had designed the signal layouts for this location under the original scope. Now, Fort Bend County requires this signal to be bid and constructed separately from the other two signals from the original package.
- In addition, Fort Bend County has requested the median noses on the north and west be trimmed back to accommodate perpendicular crosswalks. At this time, some of these crosswalks are on a slight skew.
- EPIC shall also redesign the ramps/sidewalks in the NW corner and the ramp in the NE corner to tie all of the above together.

PS&E

Following are the anticipated general design sheets for this separate bid package:

- Coversheet & Index - new
- Construction Notes and Traffic Signal Notes
- Basis of Estimate – new
- Existing Condition Layout
- Proposed Signal Layout(s)
- Median Nose Modifications /Wheel Chair/Pad Layout - new
- Crosswalks, Stop Bar, Signing & Striping Layout(s) - modified
- Standard Detail Drawings, as required

Please refer to the original scope for all other scope-related items.

COMPENSATION FOR BASIC SERVICES

The estimated additional lump sum fee for traffic signal design is provided below. Please see Attachment A for further details on man-hours and cost breakdown.

Design Phase:
\$ 6,561 (EPIC)

Contract Phase:
\$ 2,433 (EPIC)

Construction Phase:
\$ 2,586 (EPIC)

The fee includes labor and non-labor reimbursable expenses required for this project. Work not specifically stated above is considered additional effort and is subject to negotiation. Invoices shall be lump sum and submitted monthly showing percent work complete.


NOTE: EPIC's construction phase services include attending pre-construction and construction staking meetings. Fort Bend County does not require EPIC to review contractor submittals, shop drawings, contractor invoices or perform final inspection.

SCHEDULE

Additional design work on the traffic signals as defined above can be completed within 5 to 10 calendar days after receiving Notice to Proceed. If for some reason the schedule needs to be revised, it shall be done at the discretion of Fort Bend County. This schedule includes a reasonable time necessary for agency review, utility coordination and for performing the topographic survey.

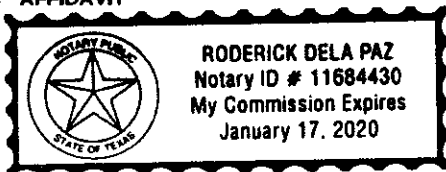
