WHEREAS, on August 25, 2016 the Texas Transportation Commission approved Minute Order Number 114680 awarding §5311 funds to address census impacts; and,

WHEREAS, it has become necessary to amend that project grant agreement;

AGREEMENT

1. Description of Amended Items

This amendment adds the FY 2016 Vehicle Revenue Miles award of \$578,782 as well as the FY 2016 Census Impact award of \$2,921 to the project grant agreement. The maximum amount payable without modification in ARTICLE 3. COMPENSATION of the grant agreement is revised to \$853,023.

This amendment also revises Attachment A – Approved Project Description to reference Project Records and Reports, Audit and Close Out Standards, and DBE Participation.
