**AMENDMENT TO AGREEMENT FOR
 DESIGN/BUILD PAVILION AT KITTY HOLLOW PARK
 Q17-055**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Apex Consulting Group, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Design/Build Pavilion at Kitty Hollow Park on May 9, 2017, (hereinafter "Agreement") pursuant to Q17-055; and


WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional seven thousand eight hundred ninety-eight dollars and 50/100 (\$7,898.50) for additional site preparation services as described in the estimate attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed one hundred thirty-three thousand eight hundred twenty dollars and 50/100 (\$133,820.50), authorized as follows:
 \$125,922.00 under the Agreement; and
 \$7,898.50 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without a written agreement executed by the parties.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

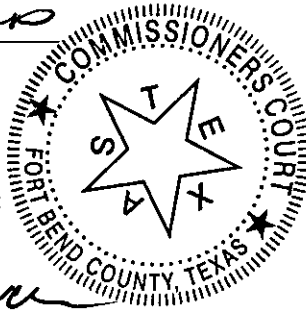



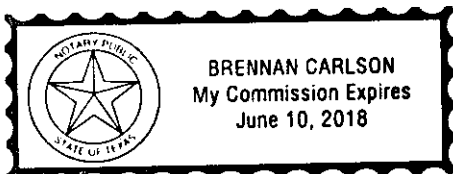
