INTERLOCAL COOPERATION AGREEMENT FOR
THE COLLECTION OF SPECIAL ASSESSMENTS
ENCLAVE AT RIVER PARK PUBLIC IMPROVEMENT DISTRICT

This Interlocal Agreement (hereinafter referred to as "Agreement"), is made and entered into pursuant to the Interlocal Cooperation Act, Chapter 791 of the Texas Government Code and Section 6.24 of the Texas Property Tax Code, by and between FORT BEND COUNTY, TEXAS (hereinafter referred to as "County"), acting through its governing body, FORT BEND COUNTY COMMISSIONERS COURT, and the CITY OF SUGAR LAND, TEXAS for Enclave at River Park Public Improvement District (hereinafter referred to as "ENCLAVE AT RIVER PARK PID"), duly organized and existing under the laws of the State of Texas, acting by and through the City Council of the City of Sugar Land (hereinafter referred to as "City Council").

RECITALS

WHEREAS, City Council has the authority to authorize County to act as tax assessor/collector for ENCLAVE AT RIVER PARK PID, and County has the authority to so act; and,

WHEREAS, the Fort Bend County Tax Assessor/Collector has approved this Agreement; and,

WHEREAS, City Council and County believe it is in the best interests of the citizens of Fort Bend County to enter into this Agreement; and,

NOW THEREFORE, County and City Council for the mutual consideration hereinafter stated, agree as follows:

ARTICLE I
PURPOSE

The purpose of this Agreement is to designate and allow the Fort Bend County Tax Assessor/Collector as the tax assessor/collector for ENCLAVE AT RIVER PARK PID for the collection of special assessments, including penalties, interest and attorney's fees for the collection of assessments owed ENCLAVE AT RIVER PARK PID.

ARTICLE II
TERM

2.01 This Agreement shall be effective on the date the last party executes this Agreement and shall terminate on June 30, 2018.

- 2.02 This Agreement shall automatically renew thereafter for four (4) additional one (1) year terms on an annual basis unless sooner terminated as provided herein.
- 2.03 City Council may terminate this agreement at any time by providing ninety (90) days advanced written notice to County.
- 2.04 County may terminate this agreement by providing written notice to City Council no later than six (6) months in advance of the expiration of the initial term of this Agreement or any renewal term.
- 2.05 In the event of termination of this Agreement by City Council, City Council shall assume all contractual obligations entered into with County for services rendered to ENCLAVE AT RIVER PARK PID for the duration of the term of the Agreement and any renewal, and County shall be relieved of all contractual obligations under this agreement.
- 2.06 As soon as practicable after the date of termination or the expiration of this Agreement, the County shall submit a final report containing the information set forth in Article III. At that time, distribution of the amount due to ENCLAVE AT RIVER PARK PID shall be made or ENCLAVE AT RIVER PARK PID shall be invoiced for any amounts due from ENCLAVE AT RIVER PARK PID pursuant to the terms of this Agreement. Payments are to be made on or about thirty (30) days after receipt of an invoice. Copies of all reports and all records of ENCLAVE AT RIVER PARK PID shall be delivered to City Council when and if this Agreement is terminated or upon its expiration if not sooner terminated.

ARTICLE III OBLIGATIONS OF COUNTY

- 3.01 For the purposes and consideration herein stated and contemplated, County shall provide special assessment services by and through the Fort Bend County Tax Assessor/Collector for ENCLAVE AT RIVER PARK PID for public improvement accounts within the jurisdiction of ENCLAVE AT RIVER PARK PID.
- 3.02 City Council hereby designates the County Tax Assessor/Collector as its Tax Assessor/Collector for purposes of compliance with Chapter 26 of the Texas Property Tax code, as amended, for Fort Bend County.
- 3.03 County shall perform all the duties required by law of the Tax Assessor-Collector of ENCLAVE AT RIVER PARK PID with regard to assessing and collection of public improvement special assessments.
- 3.04 City Council hereby expressly authorizes County to do and perform all acts necessary and proper to collect special assessments for ENCLAVE AT RIVER PARK PID, including but not limited to:
 - A. Preparation of current and delinquent assessment rolls, pro-ration of assessments, correction of clerical errors in assessment rolls, collection of current liabilities, collection of delinquent assessments, and issuance of refunds.
 - B. Assessment and collection of special assessments owing to ENCLAVE AT RIVER PARK PID. The term "assess" does not

- include those functions defined as "appraisal" by the Property Tax Code.
 - C. Production of a consolidated tax/special assessment statement for both County and ENCLAVE AT RIVER PARK PID taxes/assessments.
 - D. Preparation and consolidation of tax/special assessment statements for each parcel on the assessment rolls of ENCLAVE AT RIVER PARK PID.
 - E. Mailing tax/special assessment statements.
 - F. Mailing notices of delinquent service charges in accordance with Section 33.07, 33.08 and 33.11 of the Texas Property Tax Code.
 - G. The performance for City Council of all duties provided by law of the State of Texas for the collection of taxes.
 - H. The performance of any additional, reasonable services which may be requested in writing by City Council and as agreed to by the Fort Bend County Tax Assessor/Collector.
- 3.05 County shall provide the following reports, upon request, by City Council:
- A. Report of the current year special assessment levy, showing assessment value, exemptions, abatements, net taxable values, special assessment rate, and special assessment levy for each parcel of property subject to ENCLAVE AT RIVER PARK PID;
 - B. Remittance report with each remittance to City Council showing the assessments paid by year, amount paid, principal and interest paid, service charge paid, etc.;
 - C. Monthly report of special assessment activity showing the amount of initial levy, collections during month for both current and delinquent special assessments, adjustments during the month, and the year-to-date collections percentage of current levy; and
 - D. Any additional reports which may be requested by City Council.
- 3.06 The special assessments collected by County for ENCLAVE AT RIVER PARK PID shall be remitted as follows:
- A. A credit/debit memo within same depository bank; or
 - B. by ACH; or
 - C. by wire to ENCLAVE AT RIVER PARK PID's designated depository or agent; or
 - D. by check mailed to ENCLAVE AT RIVER PARK PID.
- 3.07 City Council shall provide written notification to County of the manner in which special assessments shall be remitted, as described in Section 3.06 above.
- 3.08 The special assessments collected by County shall be remitted to ENCLAVE AT RIVER PARK PID on a daily basis for the period beginning December 1st and ending February 15th of each year. Remittance at other times during the year shall be at least once per week.
- 3.09 Wire transfers shall incur a charge of five dollars (\$5.00) for each transfer.
- 3.10 Refunds to special assessment payers and special assessment checks returned from banks shall be deducted from the County's remittance to ENCLAVE AT RIVER PARK PID.

ARTICLE IV
OBLIGATIONS OF ENCLAVE AT RIVER PARK PID

- 4.01 ENCLAVE AT RIVER PARK PID has levied the special assessments and shall report to County the special assessments due on each lot within ENCLAVE AT RIVER PARK PID by October 1 of each year. In the event the special assessment is reported subsequent to October 1 of any year, ENCLAVE AT RIVER PARK PID shall reimburse County for any additional costs incurred, in accordance with this Article.
- 4.02 ENCLAVE AT RIVER PARK PID agrees to promptly deliver to County all records necessary to perform its duties under the terms of this Agreement.
- 4.03 For services rendered pursuant to this Agreement, ENCLAVE AT RIVER PARK PID agrees to pay County the following amounts, which the Parties agree is reasonable compensation as allowed by Tax Code Section 6.27:
 - A. Thirty-five cents (\$0.35) per parcel per year;
 - B. Other costs for which ENCLAVE AT RIVER PARK PID will reimburse the County for actual costs incurred for any additional services provided.
- 4.04 ENCLAVE AT RIVER PARK PID shall pay to County the cost of assessment and collection as provided in Section 4.03. The payment shall be remitted to County after the mailing of consolidated tax/special assessment statements and no more than 30 days after receipt of County itemized invoice.

ARTICLE V
ADMINISTRATIVE PROVISIONS

- 5.01 All records necessary to be maintained by County for the assessment and collections of special assessments shall be kept clearly on the books and records of County, and a designated representative of ENCLAVE AT RIVER PARK PID, including district auditors, is authorized to examine the records maintained by County at such reasonable time and interval as ENCLAVE AT RIVER PARK PID deems necessary. Such books and records will be kept in the offices of County.
- 5.02 ENCLAVE AT RIVER PARK PID may maintain, at their own cost, a Public Fidelity Bond covering all offices, officials and employees in the amount of one hundred thousand dollars (\$100,000.00).
- 5.03 ENCLAVE AT RIVER PARK PID shall transfer to the possession and control of County, without charge, copies of all records necessary for the performance of the duties and responsibilities of County pursuant to this Agreement, which shall include all special assessment records, including the delinquent special assessment rolls.
- 5.04 Neither the County nor the County Tax Assessor/Collector shall be legally responsible to ENCLAVE AT RIVER PARK PID for any failure to collect

- assessments unless the failure results from the failure to perform the duties imposed by the law or by this Agreement.
- 5.05 ENCLAVE AT RIVER PARK PID reserves the right to institute such suits for the collection of delinquent assessments as ENCLAVE AT RIVER PARK PID deems necessary and to contract with an attorney for collection of delinquent assessments.
- 5.06. County shall comply with all provisions of the Texas Property Tax Code, as amended, and any mutually agreed upon written policies regarding collection of special assessments which ENCLAVE AT RIVER PARK PID may adopt.
- 5.07 In the event County waives any penalty and/or interest on any parcel, pursuant to Section 33.011 of the Property Tax Code for the taxes owed to the County, ENCLAVE AT RIVER PARK PID consents to the waiver of the penalty and/or interest on the same parcel(s), and hereby authorizes County to waive such penalty and/or interest on behalf of ENCLAVE AT RIVER PARK PID.
- 5.08 ENCLAVE AT RIVER PARK PID's performance under this Agreement is conditioned on the appropriation of funds by ENCLAVE AT RIVER PARK PID on a yearly basis for payment of the Collection Fee, and shall constitute a commitment of current revenues only. The failure by ENCLAVE AT RIVER PARK PID's governing body to appropriate funds sufficient for payment of such Collection Fee shall be grounds for termination of this Agreement.

ARTICLE VI LIABILITY

Each party to this Agreement agrees that it shall have no liability whatsoever for the actions or omissions of an individual employed by another party, regardless of where the individual's actions occurred. Each party is solely responsible for the actions and/or omissions of its employees and officers.

ARTICLE VII MISCELLANEOUS

- 7.01 This Agreement may be amended by the mutual agreement of the parties hereto in writing to be attached to and incorporated into this Agreement.
- 7.02 Venue for any litigation involving this Agreement shall be in Fort Bend County, Texas.
- 7.03 If any one or more of the provisions contained in this Agreement shall be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision thereof and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
- 7.04 This Agreement supersedes any and all other agreements, either oral or in writing

between the parties hereto with respect to the subject matter hereof, and no other agreement, statement, or promise relating to the subject matter of this Agreement which is not contained herein shall be valid or binding.

7.05 This Agreement may not be assigned by either party.

ARTICLE VIII NOTICES

Any notice required to be given under the provisions of this Agreement shall be in writing and shall be duly served when it shall have been deposited, enclosed in a wrapper with the proper postage prepaid thereon, and duly registered or certified, return receipt requested, in a United States Post Office, addressed to the Owner at the mailing address as hereinafter set out. If mailed, any notice of communication shall be deemed to be received three (3) days after the date of deposit in the United States Mail. Unless otherwise provided in this Agreement, all notices shall be delivered to the Owner or the County at the following addresses:

Either party may designate a different address by giving the other party ten (10) days written notice thereof.


ARTICLE IX ENTIRE AGREEMENT AND ATTACHMENT



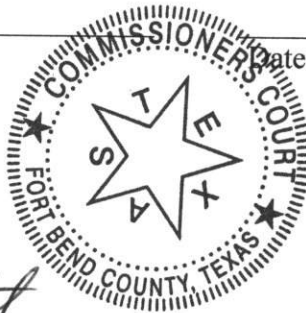
