**AMENDMENT TO AGREEMENT FOR  
 PROFESSIONAL ENGINEERING SERVICES**

**THIS AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Binkley & Barfield, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on February 28, 2017, (hereinafter "Agreement") for Services to be provided under the Fort Bend County 2013 Mobility Bond Program – A. Myers Road Extension from Berdett Road to FM 762 – Project No. 13102, pursuant to SOQ 14-025; and


WHEREAS, the parties desire to amend the Agreement for additional professional engineering and surveying Services to be provided and increase the total Maximum Compensation available to perform the Services.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional twenty-four thousand two hundred seventeen dollars and no/100 (\$24,217.00) to render additional Services to County as described in the Scope of Work attached as Exhibit "A" hereto and incorporated herein for all purposes; and
2. The Maximum Compensation payable to Contractor for all Services rendered under the Agreement and this Amendment is hereby increased to an amount not to exceed three hundred sixty-two thousand one hundred thirty-seven dollars and no/100 (\$362,137.00), authorized as follows:  
                                   \$337,920.00 under the Agreement; and  
                                   \$24,217.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written amendment executed by the parties.


Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.







**Re: Proposal for Additional Professional Services – A. Myers Road Extension  
From Berdett Road to FM 762**

Dear Mr. Barnett:

Binkley & Barfield, Inc. (BBI) is pleased to submit this proposal for the additional design of the A. Myers Road Extension widening existing A. Myers Road to Berdett Road. The fee is based upon the Scope of Work (SOW) of the additional design efforts outlined by Fort Bend County (FBC) and recent discussions with you. Refer to the original SOW for all other design efforts.

According to the drawings and information provided by LJA and Fort Bend County, BBI understands that the additional roadway segment is approximately 750 LF and will follow the 2013 Mobility Bond Program Summary of Design Process.

The additional design will be incorporated with the original project from Berdett Road to FM 762 and will follow the same design phasing and billing as previously scoped.

The additional design's scope is to widen existing A. Myers Road to match the 3-lane intersection at proposed A. Myers Road and Berdett Road with a 6' shoulder accompanying only on the eastbound lane. This roadway is to be designed within an interim 62-foot ROW.

The design schedule has been revised to accommodate the recent design additions moving forward. The 60% submittal will take place on May 31<sup>st</sup>. The meeting will take place in mid-June. Final ROW documents 90% submittal will be submitted by June 30<sup>th</sup>. FBC will review the 90% submittal and 100% Compact Discs will be submitted by July 31<sup>st</sup> to the County Purchasing Agent.

The design fee for both the additional scope is \$24,217.00 and is detailed in the attachment. This design fee includes the cost of additional survey initially completed by George Ranch High School.




