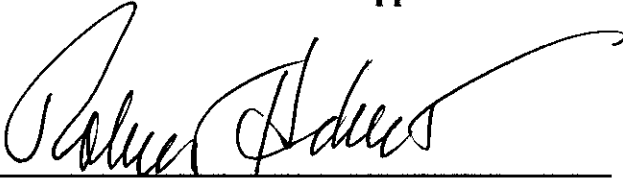

Judge Hebert stated the schedule allows the Judges to determine the cost. On more common languages, the fee will be closer to \$50 than some of the more esoteric languages. The County must provide an interpreter regardless of the language they speak comfortably.

Ed Sturdivant, County Auditor, indicated the board met last week to make a proposal to the court. It is this court's discretion on setting a fee schedule. The board plans to come back with a more detailed fee schedule. Recently, the board learned, with guidance from the County Attorney's office, the court is required to set a fee schedule if fees are paid beyond what is set out by statute.
