## **AMENDMENT TO THE CONTINUUM OF CARE PROGRAM GRANT AGREEMENT**

This Amendment to the Grant Agreement is made by and between the United States Department of Housing and Urban Development (HUD) and Ft. Bend County, Texas (the Recipient), of 301 Jackson St., Suite 602, Richmond, TX 77469.

### **RECITALS**

1. HUD and the Recipient entered into a Grant Agreement dated May 2, 2017 under Grant No. TX0353L6E001604 (the Grant Agreement).
2. The County is requesting to amend the 2016 Grant Agreement to transfer the above referenced project from Ft. Bend County, Texas to Ft. Bend Women's Center.
3. HUD has determined that the change is necessary to better serve eligible persons within the geographic area and to ensure that the priorities established under the Notice of Funding Availability under which the grant was awarded are met.
4. As of August 11, 2017, the following budget line item balances were reflected in the Line of Credit Control System:
 

a. Rental Assistance	\$237,600
b. Administrative	\$16,237

### **AGREEMENTS**

The Grant Agreement is hereby amended by replacing Fort Bend County, Texas as the recipient and transferring the project to Fort Bend Women's Center, located at 501 Highway 90 East, Richmond, Texas 77406. DUNS Number-134245419, and Tax ID number is 76-0032451. HUD's total funding amount for this grant remains the same.

This Amendment to the Grant Agreement constitutes the entire agreement of the parties as to amendment of Grant Agreement and will become effective only upon the execution hereof by all parties. The remaining terms of the Grant Agreement remain in full force and effect.

The parties, on the dates set forth below their respective signatures, hereby execute this Amendment to Grant Agreement, as follows:




