Commissioner Meyers explained when comparing the actual taxes that taxpayers paid last year and taxes paid this year, because this is a reduction of 1/2 cent on our tax rate, and with the 1/2 cent decrease being approved, the taxpayers will pay less taxes to the County. The reason this is being cited as an effective increase of 1.26%, is because of the artificial construct by the legislature which requires the County to be penalized for any payment made to a tax increment reinvestment zone. If we make \$4.5 million a year, this goes to the various TIRZ, at the request of the cities, who are using the funds to build parks, museums, roads and other infrastructure. Because of the requirement to reduce this; it artificially creates a situation where we have a tax rate increase. The reality is that citizens will pay fewer taxes as a result of our tax rate reduction.

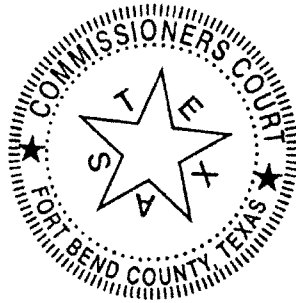
