**THIRD AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT FOR
 INTELLIGENCE ANALYSTS**

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and MVM, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Professional Services Agreement for Intelligence Analysts between Fort Bend County and MVM, Inc. on or about December 9, 2014, and as amended on September 24, 2015 and September 13, 2016 (hereinafter "Agreement"), attached hereto as Exhibit A and incorporated by reference herein for all purposes; and

WHEREAS, County desires that Contractor provide professional services for the Sheriff's Office under the High Intensity Drug Trafficking Areas Program (HIDTA) (hereinafter "Services").

WHEREAS, the parties desire to renew the term of performance for Services; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement and are incorporated by reference in the same as if fully set forth verbatim herein:

NOW, THEREFORE, the parties do mutually agree as follows:

The Agreement is hereby renewed for an additional one-year period beginning on October 1, 2017 and will terminate on September 30, 2018.

All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of the Agreement. If there is a conflict between this Third Amendment and the Agreement for Professional Services Agreement for Intelligence Analysts, the provisions of this Third Amendment shall prevail with regard to the conflict.

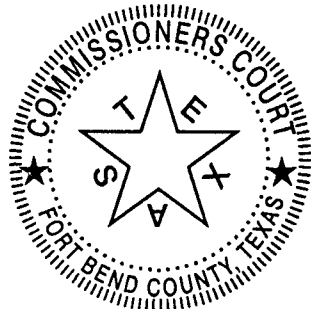
