Question from Michael Boenig (Allgood Construction Co. Inc.) at 4:19pm on 6-27-17

The plans show channel excavation along the slope paving under each bridge. I understand that spoils from the slope paving is an incidental cost to placing the slope paving, which would be the 5 inches in order to place forms and concrete. But the plans are showing to excavate the embankments on each of the bridge. In order to achieve the elevation called out on the plans we have calculated about 1700CY of dirt that needs to be removed. It seems as if there is not a bid item to for channel excavation but item 120 of the specifications seems the fit the parameters.

Should the channel excavation be a bid item that was missed since no other item relates this material and plans show excavation? Below are surveying quantities that show the amounts for each bridge. From Existing Ground to top of slope paving

We concur that the contractor should be compensated for the excavation along the concrete slope paving under each bridge.

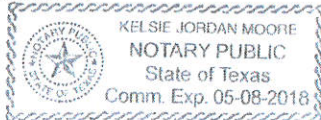
