AMENDMENT TO PROJECT MANAGEMENT AGREEMENT

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and LJA Engineering, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Project Management Agreement on February 23, 2016, (hereinafter "Agreement") pursuant to SOQ 14-025 for certain management and administrative support services for the 2013 Mobility Bond Project; and

WHEREAS, the parties desire to amend the Agreement to include additional project management services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. Services to be rendered under the Agreement shall be amended to add additional project management services, described in LJA Engineering Proposal No. 16-00531 CO dated August 30, 2017, attached hereto as Exhibit A, and incorporated herein for purposes.
2. County shall pay Contractor an additional one hundred twenty thousand dollars and no/100 (\$120,000.00) for the additional project management services to be rendered under this Amendment.
3. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred eighty thousand dollars and no/100 (\$480,000.00). In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without a written agreement executed by the parties.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

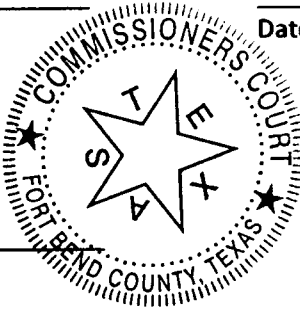

LJA Engineering, Inc. (LJA) was awarded a design management contract in February 2016 in the amount of \$360,000.00 for coordination and management of design engineers for 2013 Mobility Bond projects in Precinct 1. That fee was based upon an estimated duration and effort of 18 months on the project. LJA has now completed 18 months of effort in providing the coordination and design management services. To date four projects have bid and three additional projects are near the bid date.

By this letter, LJA. is requesting a contract modification extension of 12 months and an additional \$120,000.00 in funding. This amount is based on the management approximately of one half the original number of Precinct 1 projects and a duration of 12 months.

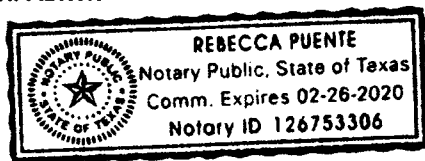
