THAT, **FORT BEND COUNTY**, a body politic organized and existing under the laws of the State of Texas (herein referred to as "Grantor"), for and in the consideration of Ten and No/100 Dollars to Grantor paid by **SOUTHCROSS GULF COAST TRANSMISSION, LTD**, its successors and assigns, (herein referred to as "Grantee"), has **GRANTED, SOLD AND CONVEYED** and by these presents, does **GRANT, SELL AND CONVEY** unto said Grantee, all or in part, a permanent and perpetual non-exclusive easement (the "Easement"), across, along, under, over, upon and through that certain tract of land located in Fort Bend County, Texas, containing **0.3627 of an acre** of land, as more particularly described and shown in Exhibit A attached hereto and made a part hereof (the "Easement Tract"), for the purposes of adjustment, removal, and/or relocation of certain facilities of Owner and to continue operation and maintenance of such facilities. Following completion of the construction of Grantee's Facilities, Grantee may record an amended Exhibit A, if adjustments become necessary following actual construction, that reflects the survey of the center line of the pipeline as built, and any such amended easement description shall be included within and constitute the Easement granted by Grantor herein.

Grantee shall have reasonable rights of ingress and egress to and from said Easement Tract, together with reasonable working space for any and all purposes necessary and/or incident to the exercise by the Grantee of the rights granted to it by this Agreement. Grantee shall promptly repair any damage to Grantor's property caused by Grantee so as to maintain such property in as good or better condition as existed prior to use by Grantee.

TO HAVE AND TO HOLD the above described Easement, together with all and singular the rights and appurtenances thereto in anywise belonging, unto Grantee, forever, and Grantor does hereby bind itself and its successors, heirs, assigns, and legal representatives, to fully warrant and forever defend all and singular the above described Easement and rights unto said Grantee, against every person whomsoever lawfully claiming or to claim the same or any part thereof, by, through or under Grantor, but not otherwise.

Except as provided for herein, all other terms and conditions of the original easement, recorded as Document No. 55543 in the Official Public Records of Fort Bend County, Texas, shall remain in full force and effect. Additionally, any notices required in such original easement to be given by Grantor to Grantee shall be provided to Grantee herein, and its successors and assigns.

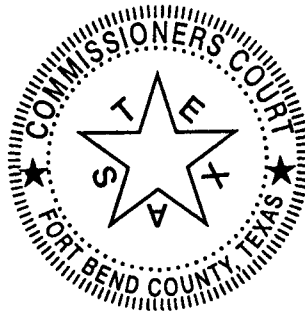

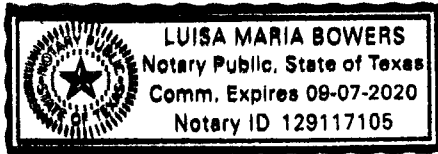

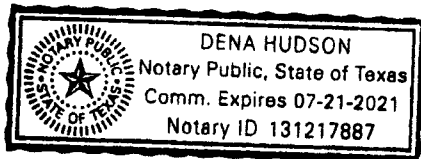

DESCRIPTION OF A 0.3627 ACRE TRACT OF LAND SITUATED
IN THE ALEXANDER PHILIPS SURVEY, ABSTRACT NO. 300
FORT BEND COUNTY, TEXAS

BEING a 0.3627 acre (15,801 square feet) tract of land situated in the Alexander Philips Survey, Abstract No. 300 of Fort Bend County, Texas and being a portion of a called 34.2300 acre tract of land as described in a conveyance to Live Oak Ranch, Inc. recorded under Fort Bend County Clerk's File Number (F.B.C.C.F. No.) 2002107809, said 0.3627 acre tract of land described by metes and bounds as follows:

COMMENCING at a 1-inch iron pipe found for the northeast corner of said 34.2300 acre tract, lying on the west right-of-way line of Flewellen Katy Road (60 feet wide), same being the southeast corner of AVALON AT SPRING GREEN SEC. 1, a subdivision plat recorded under Plat No. 20130093 of the Fort Bend County Plat Records (F.B.C.P.R.);

THENCE, S 87°59'24" W, along the south line of said AVALON AT SPRING GREEN SEC. 1, a distance of 25.57 feet to a 1/2-inch iron pipe with cap stamped "Brown & Gay" set for the **POINT OF BEGINNING** and the northeast corner of the herein described tract, same being the beginning of a non-tangent curve to the right, from which its center bears N 70°27'49" W, 2,550.00 feet;

THENCE, over and across said 34.2300 acre tract the following courses and distances:

In a Southwesterly direction, along said curve to the right, a distance of 378.05 feet, having a radius of 2,550.00 feet, a central angle of 08°29'40" and a chord which bears S 23°47'01" W, 377.71 feet to a 1/2-inch iron pipe with cap stamped "Brown & Gay" set for the point of tangency;

S 28°01'51" W, a distance of 195.85 feet to a 1/2-inch iron pipe with cap stamped "Brown & Gay" set for the beginning of a tangent curve to the right;

In a Southwesterly direction, along said curve to the right, a distance of 6.95 feet, having a radius of 85.00 feet, a central angle of 04°41'10" and a chord which bears S 30°22'26" W, 6.95 feet to a 1/2-inch iron pipe with cap stamped "Brown & Gay" set for an interior corner of the herein described tract;

S 30°26'47" E, a distance of 118.29 feet to a 1/2-inch iron pipe with cap stamped "Brown & Gay" set for the beginning of a non-tangent curve to the left, from which its center bears S 66°33'57" E, 170.00 feet;

In a Southerly direction, along said curve to the left, a distance of 41.16 feet, having a radius of 170.00 feet, a central angle of 13°52'17" and a chord which bears S 16°29'55" W, 41.06 feet to a 1/2-inch iron pipe with cap stamped "Brown & Gay" set for the south corner of the herein described tract;



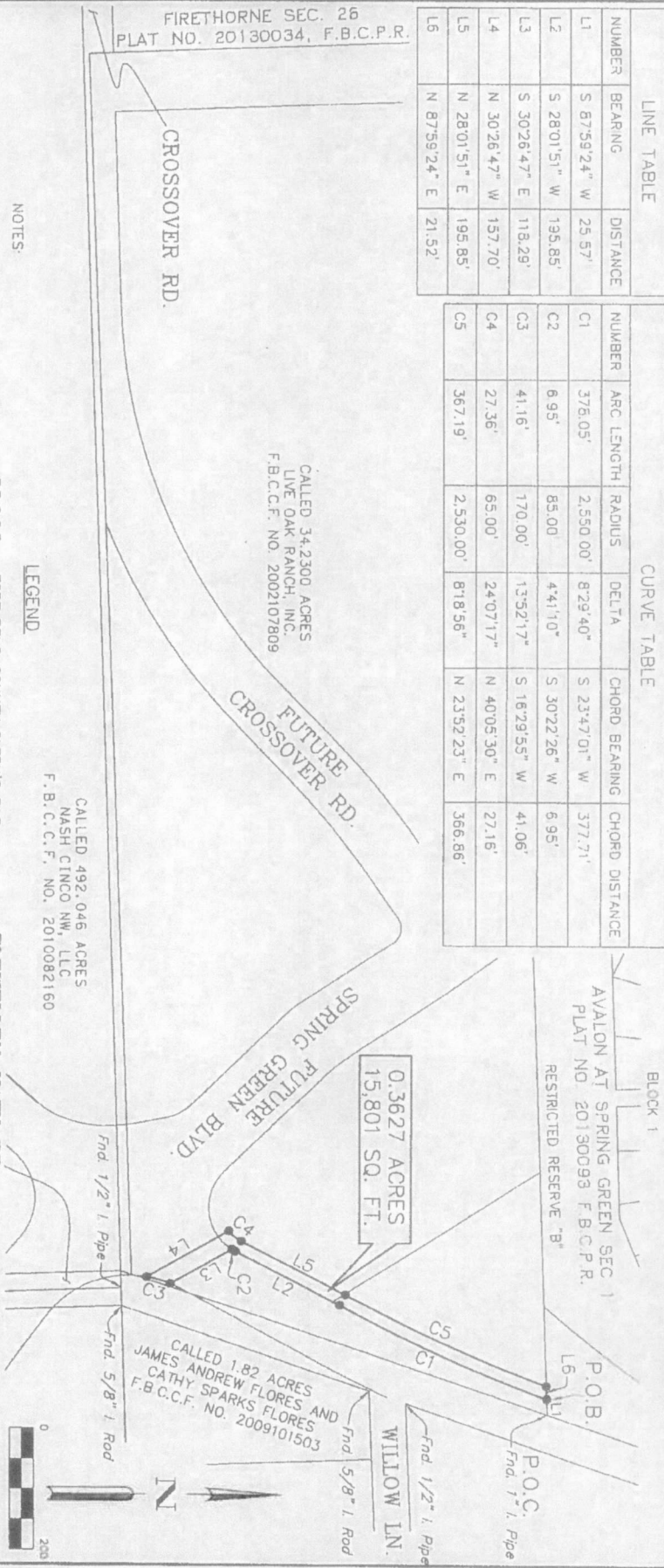

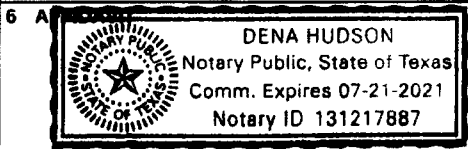
