**SECOND AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Binkley & Barfield, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on February 28, 2017, (hereinafter "Agreement") for Services to be provided under the Fort Bend County 2013 Mobility Bond Program – A. Myers Road Extension from Berdett Road to FM 762 – Project No. 13102, pursuant to SOQ 14-025, as amended by document dated July 25, 2017; and

WHEREAS, the parties desire to amend the Agreement for additional professional engineering and design Services to be provided and increase the total Maximum Compensation available to perform the Services.


NOW, THEREFORE, the parties do mutually agree as follows:


1. County shall pay Contractor an additional thirty-six thousand three hundred sixteen dollars and no/100 (\$36,316.00) to render additional Services to County as described in the Proposal for Additional Professional Services attached as Exhibit "A" hereto and incorporated herein for all purposes; and
2. The Maximum Compensation payable to Contractor for all Services rendered under the Agreement and this Amendment is hereby increased to an amount not to exceed three hundred ninety-eight thousand four hundred fifty-three dollars and no/100 (\$398,453.00), authorized as follows:
 - \$337,920.00 under the Agreement;
 - \$24,217.00 under the Amendment; and
 - \$36,316.00 under this Second Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement, the Amendment and this Second Amendment exceed the Maximum Compensation without written amendment executed by the parties.

Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.

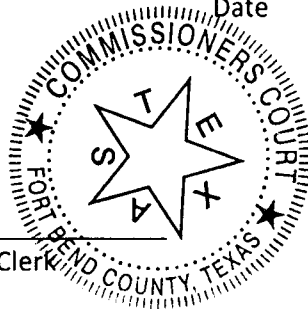





Dear Mr. Barnett:

Binkley & Barfield, Inc. (BBI) is pleased to submit this proposal for the additional design of the A. Myers Road Extension for the widening of Berdett Road. The fee is based upon the Scope of Work (SOW) of the additional design efforts outlined by Fort Bend County (FBC) and recent discussions with you. Refer to the original SOW for all other design efforts.

The additional scope will be to widen Berdett Road to accommodate a turn lane traveling north and south to access A. Myers Road. This will entail modifying several existing sheets and adding additional sheets. Included in this proposal is the additional survey along Berdett Road FM 762.

The preliminary design will commence prior to survey completion, in order to be combine with the current set for letting purposes. Once the survey is complete (30 calendar days from authorization), the final set will be re-issued within 2 weeks.

The design fee for both the additional design scope and survey is \$36,316.00 and is detailed in the attachment.

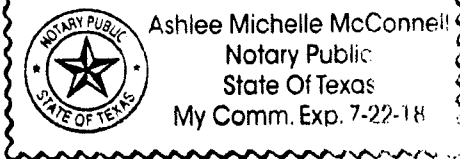
