## SECOND AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING INSPECTION SERVICES

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of HJ Consulting, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Inspection Services on February 23, 2016, (hereinafter "Agreement"), as amended by document dated August 22, 2017, (hereinafter "Amendment") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation to complete the additional services.

## NOW, THEREFORE, the parties do mutually agree as follows:

- County shall pay Contractor an additional thirty thousand dollars and no/100 (\$30,000.00) to continue inspection services until project completion under the Agreement as described in the Request for Additional Funds dated November 20, 2017 attached as Exhibit "A" hereto and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed five hundred seventy-five thousand dollars and no/100 (\$575,000.00), authorized as follows:

\$450,000.00 under the Agreement; \$95,000.00 under the Amendment; and \$30,000.00 under this Second Amendment.

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further amendment executed by the parties.

Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.
