

From the USACE Galveston District, head north on I-45. Take exit 32 for Sam Houston Tollway W. Head west on Sam Houston Tollway. Take exit for S Post Oak Road. Turn right onto Farm-to-Market Road 2234 (McHard Road). The tract is on the left located south of the existing Chimney Rock Rd.

18. Nature of Activity (Description of project, include all features)

In order to construct the proposed project, the Applicant proposes to fill 3.9 acres of jurisdictional adjacent wetlands in order to extend the existing Chimney Rock Rd.

19. Project Purpose (Describe the reason or purpose of the project, see instructions)

The purpose of the proposed fill activity is to extend Chimney Rock Rd. The proposed Chimney Rock Road extension will provide a direct connection between McHard Road (FM 2234) and Trammel Fresno Road, and complete the connection between State Highway (SH) 6 and the Sam Houston Tollway. This roadway connection is needed in order to meet the growing transportation demands associated with future population growth in this region of Fort Bend County.


