## **LEASE RENEWAL AGREEMENT - RFP 15-041**

This Lease Renewal Agreement is made by and between FORT BEND COUNTY DRAINAGE DISTRICT ("Lessor") and FORT BEND COMMUNITY REVITALIZATION PROJECTS ("Lessee").

WHEREAS, on February 3, 2015, Lessor and Lessee entered into a Lease Agreement for certain premises, being land and improvements located at 1004 Blume Road, Rosenberg, Fort Bend County, Texas (the "Leased Premises"), which was renewed for additional one year terms on September 22, 2015, September 27, 2016, and on October 10, 2017; and

WHEREAS, under the terms of the Lease Agreement, the Term of the Lease may be renewed annually upon agreement of both parties; and

WHEREAS, both the Lessor and Lessee desire to renew the Term of the Lease for an additional twelve (12) months and remain in effect through September 30, 2019, under the same terms of the original Lease Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL BENEFITS HEREIN CONTAINED, IT IS AGREED said Lease Agreement is amended as follows:

RENEWAL OF TERM. The Term of the Lease Agreement is hereby renewed for an additional term of twelve months, commencing October 1, 2018 and ending on September 30, 2019.

FULL FORCE AND EFFECT. Except as modified herein, all other terms and conditions of the Lease Agreement shall continue and remain in full force and effect.
