**THIRD AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING INSPECTION SERVICES**

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and HJ Consulting, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Inspection Services on February 23, 2016, (hereinafter "Agreement"), pursuant to SOQ 14-025, as amended by documents dated August 22, 2017, (hereinafter "Amendment") and December 12, 2017, (hereinafter "Second Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided for the construction of Phase 2A of the Project and increase the total Maximum Compensation to complete the additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional three hundred thirty thousand dollars and no/100 (\$330,000.00) to provide all engineering inspection services as described in the Proposal and Fee Estimate for Construction Inspection Services dated November 20, 2017 attached as Exhibit "A" hereto and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed nine hundred five thousand dollars and no/100 (\$905,000.00), authorized as follows:
 - \$450,000.00 under the Agreement;
 - \$95,000.00 under the Amendment;
 - \$30,000.00 under the Second Amendment; and
 - \$330,000.00 under this Third Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further amendment executed by the parties.
4. The Time of Performance under the Agreement is hereby extended to end no later than March 31, 2019.

Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.

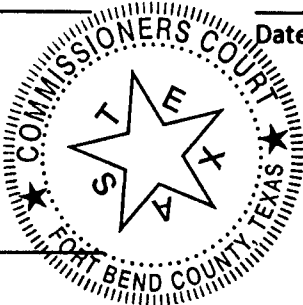

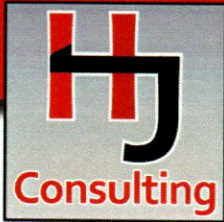

Scope of Services

Billing Rate

Inspector	\$125.00 per hour
Reimbursable Expenses	\$1500.00 per month

Fees are based on hourly rates and on the time spent by the personnel who work on the job. Billing rates are based on experience of our staff and may need to be adjusted periodically to retain the best personnel.
