## ORDER OF EXCLUSION AND DISANNEXATION

## **RECITALS**

WHEREAS, certain segments of roadways identified in Exhibit A, attached hereto and incorporated herein for all purposes and hereinafter referred to as the "Fry Road and Mason Road Segments", are currently located within the original boundaries of Fort Bend County Assistance District No. 9 ("CAD No. 9); and

WHEREAS, Fort Bend County Assistance District No. 1 ("CAD No. 1") is situated with boundaries near or adjacent to the boundaries of CAD No. 9; and

WHEREAS, the Fry Road and Mason Road Segments are better suited geographically for inclusion within the boundaries of CAD No. 1; and

WHEREAS, the Board of Directors of CAD No. 9 desires to exclude the Fry Road and Mason Road Segments so as to be situated outside of the boundaries of CAD No. 9 and eligible for inclusion within the boundaries of CAD No. 1; and

WHEREAS, Section 387.003(j) of the Texas Local Government Code permits a commissioners court by order, to exclude an area from the district if the district has no outstanding bonds payable wholly or partly from sales and use taxes and the exclusion of the land does not impair any outstanding district debt or contractual obligation; and

WHEREAS, the Board of Directors of CAD No. 9 finds that there are no outstanding bonds payable wholly or partly from sales and use taxes and the exclusion of the Fry Road and Mason Road Segments does not impair any outstanding CAD No. 9 debt or contractual obligation; and

BE IT ORDERED BY THE COMMISSIONERS COURT SITTING AS THE BOARD OF DIRECTORS OF CAD NO. 9 THAT:

- Section 1: The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete and are incorporated herein.
- <u>Section 2:</u> The Fry Road and Mason Road Segments are hereby excluded from the boundaries of CAD No. 9 by disannexation.
  - <u>Section 3:</u> This Order is effective immediately upon passage.




CAD 9 Disannexation
