**AMENDMENT TO AGREEMENT FOR FORT BEND COMMUNITY
 REVITALIZATION PROJECTS FUNDING
 FOR THE FRESNO/ARCOLA AREA**

THIS AMENDMENT, is made and entered into by and between Fort Bend County, a body corporate and politic under the laws of the State of Texas, (hereinafter "County"), and Fort Bend Community Revitalization Projects, aka Fort Bend Corps, a non-profit, Texas corporation (hereinafter "Corps"), acting by and through its duly authorized representative.

WHEREAS, the parties executed and accepted that certain Agreement for funding on December 13, 2016, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to extend the Term under the Agreement to allow completion of its obligations and services to be provided thereunder.


NOW, THEREFORE, the parties do mutually agree as follows:

1. The parties hereby agree that all terms and conditions of the Agreement have remained in effect and unchanged from the County's initial formal approval, and shall be extended to end no later than March 31, 2018.
2. Certain State Law Requirements for Contracts
 - a. Agreement to Not Boycott Israel Chapter 2270 Texas Government Code: By signature below, Corps verifies it does not boycott Israel and will not boycott Israel during the term of this Agreement.
 - b. Texas Government Code Section 2251.152 Acknowledgment: By signature below, Corps represents pursuant to Section 2252.152 of the Texas Government Code, that it is not listed on the website of the Comptroller of the State of Texas concerning the listing of companies that are identified under Section 806.051, Section 807.051 or Section 2253.153.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

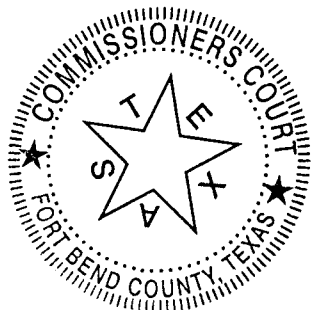
