THAT, COTTONWOOD HOMEOWNERS ASSOCIATION, INC., a non-profit corporation organized under the laws of the State of Texas ("Grantor"), for and in consideration of the sum of TEN DOLLARS (\$10.00) and other valuable consideration to the undersigned in hand paid by the Grantee herein named, the receipt and sufficiency of which are hereby acknowledged, has GRANTED, GIVEN AND CONVEYED, and by these presents does GRANT, GIVE AND CONVEY unto FORT BEND COUNTY, TEXAS ("Grantee"), a body corporate and politic under the laws of the State of Texas and unto its successors, and assigns, a temporary easement for the right of access, ingress, regress and egress (the "Easement") across, along, under and upon certain tracts of land described herein (the "Easement Property"), to allow access of a person, vehicle, machinery, equipment, and any other desired or necessary items over and across the Easement Property for so long as necessary for Grantee to complete improvements to any adjacent roadways, to wit:

Reserve A of Cottonwood, Section Three-A, an addition to the City of Rosenberg, Fort Bend County, Texas, according to the map or plat thereof recorded as County Clerk's File No. 2014016235 and as Plat No. 20140030 of the Plat Records of Fort Bend County, Texas;

Reserve A of Cottonwood, Section Three-B, an addition to the City of Rosenberg, Fort Bend County, Texas, according to the map or plat thereof recorded as County Clerk's File No. 2015007007 and as Plat No. 20150011 of the Plat Records of Fort Bend County, Texas;

Reserve A of Cottonwood, Section Three-C, an addition to the City of Rosenberg, Fort Bend County, Texas, according to the map or plat thereof recorded as County Clerk's File No. 2015031089 and as Plat No. 20150082 of the Plat Records of Fort Bend County, Texas; and

Reserve B of Cottonwood, Section Four-B, an addition to the City of Rosenberg, Fort Bend County, Texas, according to the map of plat thereof recorded as Plat No. 201000117 of the Plat Records of Fort Bend County, Texas.

This conveyance is made subject to any and all easements, conditions, restrictions, covenants, mineral or royalty interests, mineral reservations, surface waivers, utility conveyances, liens, encumbrances, regulations or orders of municipal and/or other governmental authorities, if any, or other matters of record in Fort Bend County, Texas, to the extent the same are validly existing and applicable to the Easement Property (collectively, the "Permitted Encumbrances").

Subject to the matters set forth herein, Grantor does hereby bind itself, its successors and assigns, to WARRANT AND FOREVER DEFEND, all singular the Easement and other rights described herein unto Grantee, its successors and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof, subject only to the Permitted Encumbrances.
