FIRST AMENDMENT TO AGREEMENT FOR PURCHASE OF TRANSIT BUSES RFP 17-044

THIS FIRST AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Texas Bus Sales, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties have executed and accepted that certain Agreement for Purchase of Transit Bus Services (the "Agreement"), attached herein as Exhibit A, on or about February 13, 2018; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement and incorporated by reference in the same as if fully set forth verbatim herein;

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. Any references in the Agreement to ADA Passenger Van, TYPE 1 shall be removed from this Agreement. The parties agree that the Agreement shall not include the purchase of any ADA Passenger Vans, TYPE 1, as described in this Agreement.
- 2. In addition, the parties agree to include the following clauses as required by Texas law and which are included by County regardless of content.
 - a. Agreement to Not Boycott Israel Chapter 2270 Texas Government Code: By signature below, Contractor verifies Contractor does not boycott Israel and will not boycott Israel during the term of this Agreement.
 - b. <u>Texas Government Code Section 2251.152 Acknowledgment</u>: By signature below, Contractor represents pursuant to Section 2252.152 of the Texas Government Code, that Contractor is not listed on the website of the Comptroller of the State of Texas concerning the listing of companies that are identified under Section 806.051, Section 807.051 or Section 2253.153

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this First Amendment and the Agreement, the provisions of this First Amendment shall prevail with regard to the conflict.
