## PETITION AND CONSENT BY LANDOWNER TO THE INCLUSION OF REAL ESTATE TO FORT BEND COUNTY ASSISTANCE DISTRICT NO. 4

Fort Bend County, (referred to herein as the "Petitioner"), is the owner, either in fee, dedication, prescriptive right of way, or by permanent easement, of a certain segment of roadway situated in Fort Bend County, Texas, described in the attached Exhibit A ("West Sycamore Road Segment"), and incorporated herein for all purposes.

Fort Bend County Assistance District No. 4 ("CAD No. 4" or "District") was created and authorized to impose a sales and use tax, which may be used for the following purposes within the boundaries of the District: (1) the construction, maintenance, or improvement of roads or highways; (2) the provision of law enforcement and detention services; (3) the maintenance or improvement of libraries, museums, parks, or other recreational facilities; (4) the provision of services that benefit the public health or welfare, including the provision of firefighting and fire prevention services; or (5) the promotion of economic development and tourism.

The West Sycamore Road Segment, being primarily right of way for roadway and drainage purposes adjoining or adjacent to the existing boundaries of the District, is in need of certain maintenance and improvements currently incapable of being properly served by the Petitioner. Therefore, the Petitioner hereby petitions the Board of Directors of the District to take all legal steps necessary to include the Property into the boundaries of the District.

Petitioner covenants and agrees that there are no registered voters in the area to be included in the District. Therefore, the District is not required to hold an election for inclusion of the Property or imposition of the District's current sales and use tax within the area being included.

Petitioner agrees that this Petition for inclusion of real estate shall be filed with the District and considered by the District's Board of Directors at a public meeting. Petitioner also acknowledges that the District's Board of Directors may enter an Order of Inclusion, and consent in advance to the District's Motion to include the Property within the boundaries of the District.
