The contract is changed as follows:

At the pre-construction meeting on January 5, 2018, the contractor was told that there were outstanding utility conflicts on Katy Flewellen belonging to Center Point and Comcast. The Center Point power poles and Comcast line would need to be removed/relocated prior to contractor starting construction on the Katy Flewellen portion of the project.

On April 19, 2018, Ft. Bend Project Utility Coordinator (Bryan Horton) notified AECOM and the contractor that Center Point had topped their poles on Katy Flewellen. Comcast also submitted a ROW permit to Ft. Bend County for review and approval by Fort Bend Commissioner Court.

May 08, 2018, Comcast permits were approved for relocations.

May 22, 2018, Comcast provided a work schedule with forecast that relocation of the utility to be completed by June 21, 2018, weather permitting.


To date the lines have not been relocated. Comcast has changed their relocation schedule and are now expected to finish on June 27, 2018. Center Point then follows behind Comcast to complete their relocation.

The contractor has completed all items of work that do not conflict with the existing utilities mentioned above. On June 1, 2018 the contractor submitted a modification to the storm sewer to avoid Comcast utilities. This modification was approved by the design engineer. This modification does not eliminate the conflict but allows for some progress to be made on Katy Flewellen.

Due to the utility conflict with the proposed pavement, the contractor will not finish the work on time. The contractor is requesting a time extension of 58 days. This will move the finish date from July 2, 2018 to August 29, 2018.
