

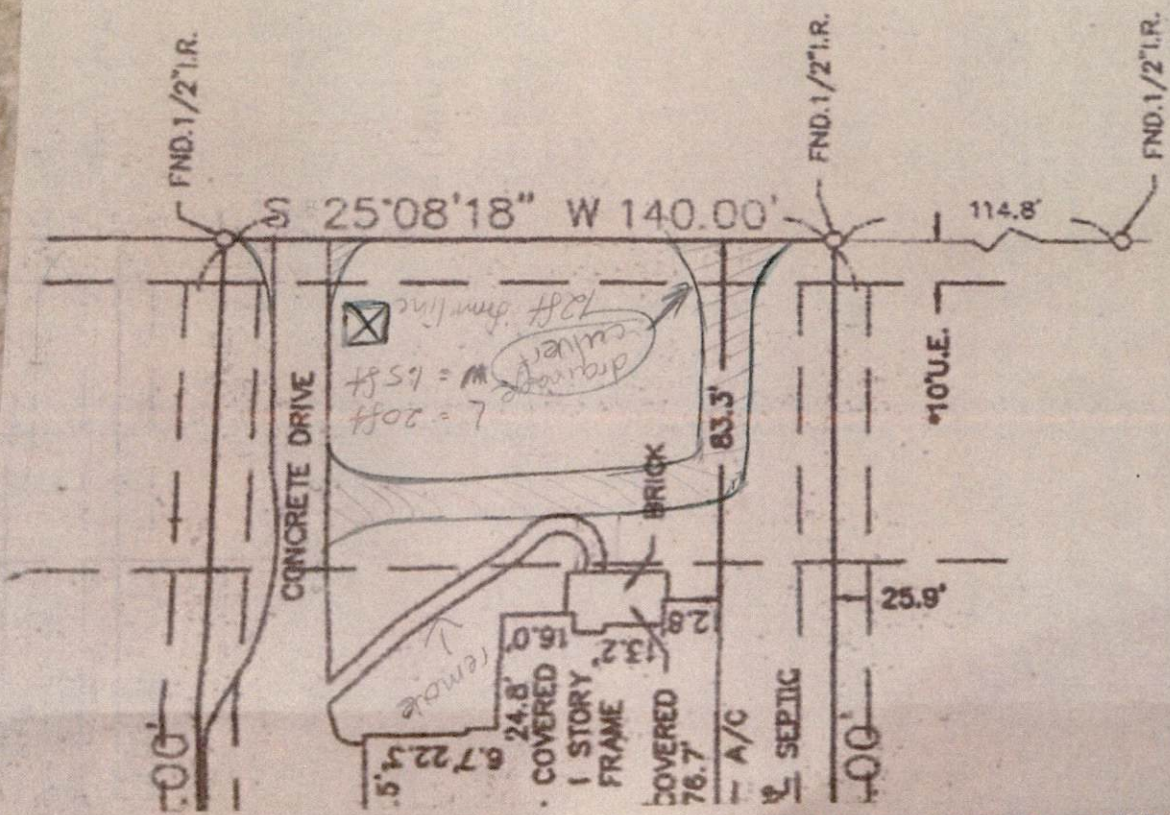


LAURABEE DRIVE (*70' R.O.W.)
