# FOURTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS FOURTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and HR Green, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on January 25, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; as amended by documents dated October 13, 2015, (hereinafter "Amendment"), April 26, 2016, (hereinafter "Second Amendment") and January 24, 2017, (hereinafter "Third Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

#### NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Contractor an additional six thousand dollars and no/100 (\$6,000.00), for a supplement to Construction Phase Services as described in Contractor's proposal dated June 1, 2018, attached hereto as Exhibit "A" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred eighty-nine thousand forty-seven dollars and no/100 (\$489,047.00), authorized as follows:

\$368,901.00 under the Agreement; \$93,846.00 under the Amendment; \$5,000.00 under the Second Amendment; \$15,300.00 under the Third Amendment; and \$6,000.00 under this Fourth Amendment.

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.

- 4. The Time of Performance for all Services to be provided by Contractor, including the additional services, is hereby extended to terminate on December 31, 2018.
- 5. Certain State Law Requirements for Contracts
  - a. Agreement to Not Boycott Israel Chapter 2270 Texas Government Code: By signature below, Contractor verifies Contractor does not boycott Israel and will not boycott Israel during the term of this Agreement.
  - b. Texas Government Code Section 2251.152 Acknowledgment: By signature below, Contractor represents pursuant to Section 2252.152 of the Texas Government Code, that Contractor is not listed on the website of the Comptroller of the State of Texas concerning the listing of companies that are identified under Section 806.051, Section 807.051 or Section 2253.153.

Except as provided herein, all terms and conditions of the Agreement and subsequent amendments shall remain unchanged.
