FIFTH AMENDMENT TO AGREEMENT FOR TRANSPORTATION SERVICES

THAT, WHEREAS, the parties executed and accepted that certain Agreement for Transportation Services on or about August 26, 2014, and as amended on August 25, 2015; August 18, 2016; August 22, 2017, and August 28, 2018 (hereinafter "Agreement"), each incorporated by reference and included herein for all purposes; and

WHEREAS, the parties desire to further amend the Agreement to extend the term for an additional period of time;

WHEREAS, the following changes are incorporated as if a part of the original Agreement as if fully set forth verbatim herein:

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. The term of the Agreement shall be extended for an additional sixty days beginning October 1, 2018, and ending on November 30, 2018.
- 2. All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect and for the term of the Agreement. If there is a conflict between this Fourth Amendment, and the Agreement, the provisions of this Fourth Amendment shall prevail with regard to the conflict.
