Dear Board of Directors:

In my official capacity as County Judge of Fort Bend County, I am pleased to submit this request for support for a grant application to The Henderson-Wessendorff Foundation for improvements to the King-Kennedy Memorial Park, located in Kendleton, Texas (Precinct 1).

Fort Bend County is currently engaged in a capital improvement project to bring much-needed enhancements to the 27-acre park. For several years park enhancements have sat dormant and Commissioner Vincent Morales' current initiative seeks to finish out improvements to this community asset. To date the County has expended \$206,435 toward enhancements including pond renovation, picnic equipment, playground mulching and basketball court resurfacing. The County is now seeking an additional \$60,000 for infrastructure improvements that include roofing, fencing, signage and abatement.

The County's Parks and Recreation Department will provide ongoing maintenance of the facility in a lease agreement with the City through 2020 with the option to renew. With the amenity improvements requested and the enhancements made to date, the park will be a well-equipped park that supports and encourages the well-being of all who come to enjoy it. To this end, I request that The Henderson-Wessendorff Foundation's Board of Directors kindly consider Fort Bend County's request for financial assistance in restoring this community asset. As an update to this request and the accompanying application documents, The George Foundation has just generously awarded \$50,000 towards upgrades for the restroom renovations. However, the award for the amenity renovations will be below the estimated budget of \$150,000 to include an asphalt walking trail.

Park enhancements have sat dormant for several years and Commissioner Morales' current initiative seeks to finish out improvements to the community asset through additional park infrastructure. The Parks and Recreation Department has provided regularly scheduled maintenance in an agreement with the City with the potential to renew in 2020.
