**FOURTH AMENDMENT TO AGREEMENT FOR  
 PROFESSIONAL ENGINEERING SERVICES**

**THIS FOURTH AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Halff Associates, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on June 2, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; as amended by documents dated December 1, 2015, (hereinafter "Amendment"), September 6, 2016, (hereinafter "Second Amendment"), and February 14, 2017, (hereinafter "Third Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided, increase the total Maximum Compensation, and extend the Time of Performance under the Agreement for the completion of such additional services.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional twelve thousand one hundred fifty dollars and no/100 (\$12,150.00), for the additional construction staking, parcel acquisition assistance, and other Services as described in Contractor's Proposal dated September 21, 2018, attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred twelve thousand six hundred dollars and no/100 (\$412,600.00), authorized as follows:
  - \$325,000.00 under the Agreement;
  - \$29,000.00 under the Amendment;
  - \$38,250.00 under the Second Amendment;
  - \$8,200.00 under the Third Amendment; and
  - \$12,150.00 under this Fourth Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
