#### DESCRIBE THE REASON FOR THE CHANGE ORDER AND WHAT IS BEING CHANGED. WHEN NECESSARY, INCLUDE EXCEPTIONS TO THIS AGREEMENT:

This change order provides for adding 51 days and 20 months of barricade handling to the contract on Trammel Fresno Road in Fort Bend County.

The contract plans were designed by BKI Inc. This construction work provides for the construction of widening a non- freeway consisting of grading, widening structure, signal, base, concrete pavement and pavement markings.

The Contractor was required to build the road from Sta. 58+48.72 to Sta. 218+96.14 as proposed in the plan sheet numbers 1 through 478 (for reference purpose only) within 622 working days with 30 months of traffic handling. The project contains special provision 008-167, which states that the Department will suspend work for 270 calendar days unless authorized in writing by the Engineer. The 270 calendar day suspension period begins from March 19, 2015 and ends on December 13, 2015.

The contractor, Williams Brothers (WB) chose to work during this period and clear the right of way so that the utility companies can relocate the infrastructures to avoid any future conflicts. As such WB worked for 27 working days starting from March 24, 2015 through April 9, 2015 (13 working days) and April 28, 2015 through May 15, 2015 (14 working days). The remaining 270 calendar day delay started from May 16, 2015. During this period, the utility companies were relocating their infrastructures.

Further, it was noted that the roadway and open cut drainage system were not matching as per the available cross sections. To remedy this situation, the consultant, RPS Klotz (for Fort Bend County Office) redesigned the roadway and prepared the revised plan sheets as required. This revision extended this 270 calendar day suspension by 7 months from December 13, 2015 to July 31, 2016. The revised plan sheets number 1 through 546 (for references only) were provided to the Contractor for their review and execution of the work as revised.

The contractor, WB re-mobilized to the project site on August 1, 2017, however the relocated utility such as AT & T buried lines have become issues which affected the contractor's ability to work on critical path items. The contractor, WB requested to suspend the time till the affected utility is out of way. This office suspended time starting September 26, 2016 through December 1, 2017. However, the utility issues were not addressed during this period and the time suspension period was extended to October 15, 2017. This second suspension period was 13 months. The total extended period for the time suspension is 20 months.

It is to be noted that the advance warning sign setup and traffic were handled during this period also. As per the updated baseline schedule, the estimated time of completion is January 2020. The contractor is required to maintain and handle barricade, till this period, however the 30 months allocated for item 502-2001-000 has been consumed by July 2017. Therefore this office is proposing to add 20 months to item 502-2001-000 to reimburse the contractor for barricade, signs and traffic handling.

In addition, the contractor, WB submitted a Time Impact Analysis Number 1 requesting to provide 58 days credit to the time charged as of April 2018 Estimate cycle. Based on the review 51 days is credited as Time extension number 1.

Fort Bend County is third party participant at 100%.

#### **EXPLANATION**

The contractor, WB submitted a Time Impact Analysis Number 1 requesting to provide 58 days credit to the time charged from October 16, 2017 through January 15, 2018 (as of January 2018 Estimate cycle) The contractor submitted a time impact analysis to support his request for 58 day credit. The request was made as the contractor could not work through the critical path items during such period.

The Time Impact Analysis was reviewed by LJA Engineering which recommends to credit 51 days instead of requested 58 days. This finding was discussed with the contractor, WB on progress meeting held on May 21, 2018 and the contractor agreed on 51 days. The LJA's finding is summarized herein below:
