FOURTH AMENDMENT TO AGREEMENT FOR JANITORIAL SERVICES PURSUANT TO RFP 16-034

THIS FOURTH AMENDMENT is made and entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and High Quality Cleaning Services (hereinafter "Contractor") a company authorized to conduct business in the State of Texas.

WITNESSETH

WHEREAS, County and Contractor executed and accepted that certain AGREEMENT FOR JANITORIAL SERVICES PURSUANT TO RFP 16-034 on or about February 23, 2016 which was amended by documents on or about March 9, 2017, December 19, 2017 and March 13, 2018 (collectively referred to as "Agreement"). County and Contractor desire to amend said Agreement as set forth below:

- I. Services to be rendered under the Agreement shall be amended to add locations for service, as described and in accordance with "2018-2019.2 Pricing and Staffing by Location" attached hereto as Exhibit A2, and incorporated herein for all purposes. The addition of these locations will be effective as of the date this Fourth Amendment is executed.
- II. The Agreement is hereby renewed; effective April 1, 2019 and shall terminate on March 31, 2020, unless terminated in accordance with the Agreement.
- III. County shall pay Contractor an additional \$1,635.00 per month for the additional services to be rendered under this Amendment, described in Exhibit A2.
- IV. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed \$107,340.00 annually.
- V. In no case shall the amount paid by County to Contractor under the Agreement or any Amendment exceed the Maximum Compensation stated for each term with

without an approved change order. The Maximum Compensation is subject to Article III, "Compensation and Payment" and Article IV "Limit of Appropriation" requirements of the Agreement; as well as any and all certification of funds signed by the Fort Bend County Auditor.

VI. Except as modified herein, any prior executed document remains in full force and effect and has not been modified or amended. If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict.

VII. Execution
