## ADDENDUM TO AGREEMENT BETWEEN FORT BEND COUNTY AND THE FORT BEND HISTORY ASSOCIATION REGARDING DEWALT HERITAGE CENTER

This Addendum to the Agreement Between Fort Bend County and the Fort Bend History Association ("Addendum") is made and entered into by and between Fort Bend County, Texas ("County"), and the Fort Bend History Association, ("FBHA"), formerly known as the Fort Bend County Museum Association, a non-profit organization authorized to do business in the State of Texas.

WHEREAS, on this same date the parties executed the AGREEMENT BETWEEN FORT BEND COUNTY AND THE FORT BEND COUNTY HISTORY ASSOCIATION ("Agreement") (which is incorporated by reference), for the County to appropriate funds to the FBHA pursuant to Local Government Code § 318.009; and

WHEREAS, the parties wish to add certain terms and conditions to the Agreement.

NOW, THEREFORE, for and in consideration of the mutual covenants, representation and other promises, and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, the Agreement is modified as follows:

- 1. The County agrees that it shall provide to the FBHA additional funds in the amount of \$25,000.00 to be expended by the FBHA in accordance with the provisions contained in the Agreement and contained herein.
- 2. The FBHA agrees to continue to work with County in preserving, developing and maintaining the Historic Dew House as the DeWalt Heritage Center (the "House"). The additional funds of \$25,000.00 herein must be used to underwrite a portion of the development cost incurred by the FBHA for the creation of a first-rate presence that fully represents the House as one of the last plantation style homes in the area and all aspects of the important DeWalt community on County history.
- 3. The FBHA is the designated recipient of these funds and is accountable that the funds are spent in an appropriate manner. In addition, the FBHA will include the reporting of these expenditures in their annual audited financial statement. The FBHA agrees that it shall include the proposed activities for the DeWalt Heritage Center in their annual budget as a separate line-item.
- 4. The County will make payments quarterly to the FBHA for the activities at the House, each payment in the amount of \$6,250 in the months of November 2018, February, May and August 2019.
- 5. The FBHA will expend the funds on the activities for the fiscal year as reflected herein below: **DeWalt Heritage Center Proposed Activities:** 
  - FBHA will continue to identify, collect, and archive oral recollections, documents, photographs and other artifacts.
  - FBHA will provide assistance for the County's facility to ensure the design is consistent with historic interpretation and allows meeting spaces for community groups and special events.
  - FBHA will collect historic items that will be highlighted throughout the House.

• FBHA will develop additional plans for a second-floor educational museum exhibit.

Except as modified herein, the terms and conditions of the Agreement to which this Addendum applies, shall remain in full force and effect and unchanged.

IN WITNESS WHEREOF, this Addendum is signed, accepted, and agreed to by all parties by and through the parties or their agents or authorized representatives. All parties hereby acknowledge that they have read and understood this Addendum and the Agreement. All parties further acknowledge that they have executed this legal document voluntarily and of their own free will.
