

**INTERLOCAL AGREEMENT BETWEEN FORT BEND COUNTY AND
DEPARTMENT OF STATE HEALTH SERVICES (DSHS) REGION 6/5 SOUTH
FOR PROCEDURE for PARTNER SERVICES WITH HIV/STI/PROGRAM
AMENDMENT No. 01**

The **FORT BEND COUNTY** ("County"), a body corporate and politic under the laws of the State of Texas, and **THE DEPARTMENT OF STATE HEALTH SERVICES** ("DSHS"), who are collectively referred to herein as the "Parties" or singularly as the "Party" herein, to that certain interlocal agreement Contract effective November 2, 2017, now desire to amend the Contract.

WHEREAS, the Parties desire to revise **SECTION VII, TIME OF PERFORMANCE**; and

WHEREAS, the Parties desire to revise **SECTION VIII, NOTICE**.

NOW, THEREFORE, the Parties hereby amend and modify the Contract as follows:

1. **SECTION VII, TIME OF PERFORMANCE**, is hereby amended to reflect a revised termination date of December 31, 2023. Notwithstanding the foregoing sentence, either Party may terminate this Contract for convenience upon 30 days written notice pursuant to Section VII. Notice of the Contract as that section is amended below.
2. **SECTION VIII, NOTICE**, is hereby amended to replace the County information in its entirety with the following:




