EIGHTH AMENDMENT TO GHG SERVICE LEVEL AGREEMENT

This Eighth Amendment to the GHG Service Level Agreement is made and entered into on by and between Fort Bend County, Texas, a body corporate and politic acting herein by and through its Commissioners Court ("County"), and GHG Corporation (hereinafter "GHG"), a Texas corporation authorized to conduct business in the State of Texas.

RECITALS

WHEREAS, County and GHG executed and accepted that certain Service Level Agreement on October 7, 2008, and as amended on or about October 6, 2009, July 6, 2010, July 8, 2014, January 27, 2015, January 26, 2016, January 3, 2017 and on or about February 6, 2018 (collectively the "Agreement"), incorporated herein by reference for all purposes; and

WHEREAS, County and GHG desire to amend the Agreement to add licenses for 150 additional users and renew the annual support and maintenance services for the electronic Clockwise Solution for the 2019 calendar year as reflected in the GHG Clockwise License Request, attached hereto as Exhibit A and incorporated herein for all purposes.

NOW THEREFORE, in consideration of the foregoing, the Agreement between County and GHG is hereby amended to read as follows:

- 1. The Agreement is hereby amended to increase the total number of licensed users from 3,100 to a total number of 3,250 users at \$10.00 per user for a total of \$1,500.00, with access to the Clockwise Solution available to all users upon execution of this Eighth Amendment through December 31, 2019.
- 2. The Agreement is hereby renewed to extend the annual support and maintenance services currently provided under the Agreement at a cost of \$6,300.00 with a new termination date of December 31, 2019.
- 3. An additional amount not-to-exceed eight thousand three hundred dollars and no cents (\$8,300.00) shall be available for payment to GHG under this Eighth Amendment as detailed in Exhibit A.
- 4. No additional funding shall be available for services by GHG provided under the Agreement and any subsequent amendment without prior written consent of County.
- 5. Certain State Law Requirements for Contracts:
 - A. Agreement to Not Boycott Israel Chapter 2270 Texas Government Code: By signature below, Contractor verifies Contractor does not boycott Israel and will not boycott Israel during the term of this Agreement.

- B. Texas Government Code Section 2251.152 Acknowledgment: By signature below, Contractor represents pursuant to Section 2252.152 of the Texas Government Code, that Contractor is not listed on the website of the Comptroller of the State of Texas concerning the listing of companies that are identified under Section 806.051, Section 807.051 or Section 2253.153.
- 6. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.

If there is a conflict between this Eighth Amendment and the Agreement, the provisions of this Eighth Amendment shall prevail with regard to the conflict.
