

**SUPPLEMENTAL AGREEMENT NO. 4

THIS SUPPLEMENTAL AGREEMENT is made and entered into this 28 day of NOVEMBER, 2018, and modifies the MASTER SERVICE AGREEMENT effective November 15, 2017 (the "Agreement"), by and between the Fort Bend Grand Parkway Toll Road Authority (the "Authority"), a Texas Local Government Corporation, and TransCore, LP (the "Contractor"), a limited partnership organized under the laws of the State of Delaware.

The Agreement is hereby modified as follows:

1. In accordance with Section 2.01 of the Agreement, the Authority and Contractor approve the addition of services evidenced by the proposal attached as an addition to **Exhibit C** to this Supplemental Agreement.


This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.


