WHEREAS, the Commissioners Court of Fort Bend County, Texas ("Commissioners Court"), has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 10 (the "District") to serve for lawful four-year terms of office expiring January 25, 2023; and

WHEREAS, the Commissioners Court desires to reappoint Rodney Vannerson to serve as Director for the District for the lawful four-year term of office commencing effective January 25, 2019, and expiring on January 25, 2023, or until his successor shall be appointed and qualified; and

WHEREAS, the Commissioners Court desires to reappoint Johnny J. Cantu to serve as Director for the District for the lawful four-year term of office commencing effective January 25, 2019, and expiring on January 25, 2023, or until his successor shall be appointed and qualified; and

WHEREAS, Rodney Vannerson is over twenty-one years of age, a resident citizen of the State of Texas, is otherwise qualified by law to serve as a Director of the District, and is not disqualified from serving as a Director of the District by reason of any law; and

WHEREAS, Title 4, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint the Directors of the District; Now Therefore,

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED BY THE COUNTY JUDGE AND COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS THAT:


Section 1: The foregoing recitals are hereby found to be true and correct.

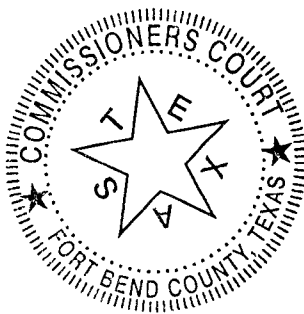

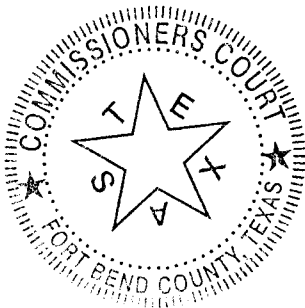


Dear Commissioner Morales and Ms. Richard:


