3. This permit expires one (1) year from date of permit if construction has not commenced.
4. This permit applies to work performed within right-of-ways owned and maintained by Fort Bend County only, and it is the responsibility of the applicant to acquire all other necessary permits.

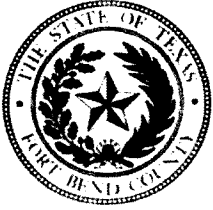



KNOW ALL MEN BY THESE PRESENTS:

THAT WE, R Construction Company whose (address, phone) is 800 Wilcrest, Suite 360, Houston, Texas, hereinafter called the Principal, and SureTec Insurance Company, a Corporation existing under and by virtue of the laws of the state of Texas and authorized to do an indemnifying business in the state of Texas, and whose principal office is located at 1330 Post Oak Blvd, Suite 1100, Houston, TX 77056, whose officer residing in the State of Texas, authorized to accept service in all suits and actions brought within said state is Steve D. It is understood that at any time Fort Bend County deems itself insecure under this bond, it may require further and/or additional bonds of the principal.

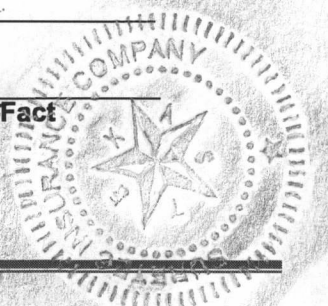

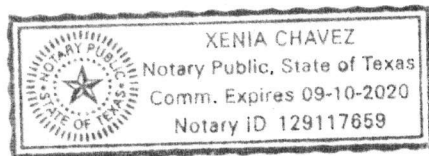

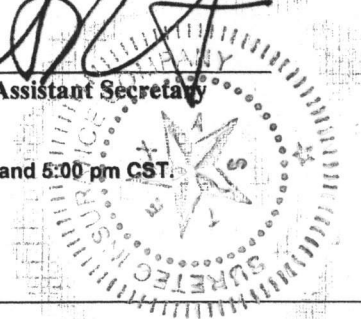
