



Judge Hebert stated most people know John Sharp as the Chancellor for Texas A&M, and as Commissioner for Texas Recovers, appointed by Governor Abbott. Mr. Sharp was a member of the State Legislature and served in the State House and State Senate. As a State Senator he did yeoman work for Fort Bend County and a small segment from Harlem Road to Plantation Blvd. was named John Sharp Boulevard to honor his service to the County. When Owens Road was realigned, the John Sharp Road was inadvertently removed. There is no record of why this road was named Owens Road, therefore, the Court believes it is important to have Owens Road renamed to John Sharp Drive to recognize his service to Fort Bend County.

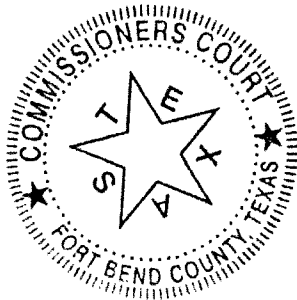
