I have examined the documents and relevant law relating to real property acquisition in connection with the above-captioned project. Because of the nature of the project (repair and protect approximately 43,470 linear feet of creek bank), there will be no relocation or displacement of persons or structures nor is there a need to acquire any interest in real estate for this project.

The Fort Bend County Drainage District (the "FBCDD") representatives previously obtained a series of Right of Way Easements from landowners along the site of the project authorizing the FBCDD to enter upon the premises of the owner and conduct the operations now contemplated under the above-captioned project. 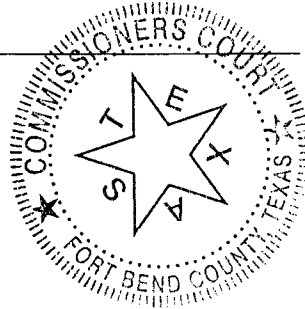
